Dear Mr. President,

In my capacity as the organizer of the XVIIth Congress of the Conference of European Constitutional Courts, I am delighted to extend an official invitation for the Circle of Presidents (Preparatory Meeting) in Batumi (**Decision VIII of September 10, 2012 in Vienna**).

Further to our letter of September 22, 2014 the Circle of Presidents will be held **on September 9-12, 2015 in Batumi, Georgia**. The Circle of Presidents will start with a reception **on September 9, 2015 at 8:00 p.m. and end on September 11, 2015 at about 9.00 p.m.** The preparatory meeting itself will be held **on September 10, 2015 from 9:00 a.m. until 12.00 p.m.** 

It should be noted that it is great honor for our country to host such a high level event. Therefore, using this opportunity, the Constitutional Court of Georgia is organizing the International Conference on September 10-11, 2015 - "Application of International Treaties by Constitutional Courts and Equivalent Bodies: Challenges to the Dialogue" which will follow the Circle of Presidents (Preparatory Meeting) and bring together the Presidents and the judges of the European Constitutional Courts and equivalent bodies, Presidents and members of the international institutions, and other dignitaries. Your participation in this conference will be greatly welcomed.
