The Circle of Presidents (preparatory meeting) will begin with the official reception on September 9 and end on September 11 with the cultural program.

Role of the Constitutional Court in Protecting Basic Constitutional Principles

- B. Judicial review of Constitutional amendments.
- C. Judicial Review of the Constitutional provisions: Is it possible to determine hierarchy between constitutional norms?
- D. The Case for unamendable (eternal) provisions of the Constitution.

I would like to use this opportunity to initiate permanent e-mail communication by establishing a special electronic mailing list of the Conference of the European Constitutional Courts in order to ensure dynamic exchange of information among the CECC member Courts and also to provide the Courts with the documents and relevant information of the Venice Commission, European Court of Justice and European Court of Human Rights and other institutions. Each Court should designate a contact person who provides us with information about recent case-laws or other significant events taking place in their courts. This information will be circulated by us among the designated contact persons of the peer Courts by email.
